### JOINT NOMINATING PETITION FOR SCHOOL BOARD

#### INSTRUCTIONS

1. Candidates (or circulator) must complete all information in "SECTION A" **prior to circulation.**
2. Candidates shall write their "**full and correct name**" on the petition, as full and correct names will appear on the General Election ballot. Any "nickname" may be placed in quotes after the candidate's given name (e.g., Michael "Mickey" Mouse).
3. If candidacy is for a regional school, be sure to include the municipality being represented in Section A.
4. Be sure to state the correct term of office in Section A; once a petition is circulated, the term cannot be amended. (Note that candidates can only file jointly if they are running for seats with the same term, *e.g., all 3-year terms.*)
5. Candidate must provide a campaign email address, which **WILL BE MADE PUBLIC.**
6. Candidates may include a designation/slogan on the ballot to appear with their name (designation is optional, is limited to three words, and cannot contain the name (or derivative thereof) of any political party that participates in a primary election).
7. The person circulating the petition must bear witness as to the signers of the petition. A minimum of 25 signatures is required on a petition.

#### CANDIDATE QUALIFICATIONS

Candidates filing a nominating petition for board membership must meet the following qualifications:

- He/She is a citizen of the United States of America.
- He/She must be at least 18 (eighteen) years of age to qualify for office.
- He/She must be able to read and write.
- He/She is a registered voter in the district.
- He/She has been a resident of the municipality from which he/she is to be elected for at least one year preceding the date of the election.
- He/She is not disqualified as a voter pursuant to *N.J.S.A. 19:4-1*.
- He/She is not disqualified from membership for the conviction of crimes pursuant to *N.J.S.A. 18A:12-1\**

No board of education member shall be directly or indirectly involved in any contract with, or claim against, the board. Consult your school district's Board Secretary for rules concerning the ability of board members to serve who have relatives working in the school district.

\*Within 30 days of election or appointment to the board, a member must undergo a criminal history background investigation through the New Jersey Department of Education.

#### SUBMISSION OF PETITION

Completed nominating petitions for candidates participating in the **November General Election** shall be filed with the **County Clerk** on or before **4 p.m. of the last Monday in July.**

Completed nominating petitions for candidates participating in the **Annual April School Election** shall be filed with the district's **School Board Secretary**; contact the board secretary for deadlines.

Candidates participating in the November election can call the County Clerk at 973-579-0900 Ext 1501 if more information is required. Candidates participating in the April election should contact their respective Board Secretary for more information.

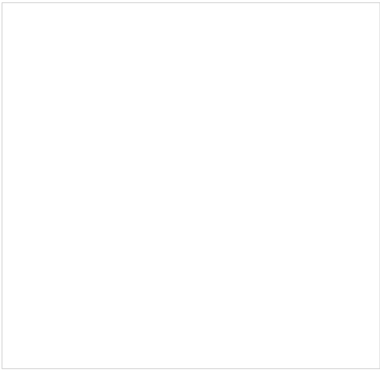
